Scope of this privacy policy

Data that is given to us by you

7. One Heritage Letting London Ltd will collect your Data in a number of ways, for example:

14. We are certified to Key Data Management system. This family of standards helps us manage your Data and keep it secure.

Data retention

Your rights

19. You have the following rights in relation to your Data:

 - b. **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** - the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
 - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
 - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
